B. Description of fixed fee services

1. Filing a patent or utility model application with an authority

Completing application particulars to applicable forms, preparing application documents and attachments, submitting same to the Authority electronically, docketing filing details and deadlines to the database, starting maintenance fee monitoring, reporting electronically, paying necessary filing fees to the account of the Authority. The package includes the delivery of a power of attorney to the Authority, if the power of attorney signed by the Client is at hand at the time of the filing of an application. The package also includes possible claiming of priority and delivery of electronic access codes of the priority documents to the Authority for the retrieval of documents, if the codes are at hand at the time of the filing of an application.

In addition to the package, most of our clients also require services that are not included in the package. For example, drafting a description of the invention and claims for the patent application and instructing for drafting of the drawings requires a considerable amount of Patent Attorney work. We will be happy to give you a cost estimate for budgeting when requested.

2. Filing a trademark or design application with an authority

Completing application particulars to applicable forms, preparing application documents and attachments, submitting same to the Authority electronically, docketing filing details and deadlines to the database, starting maintenance fee monitoring, reporting electronically, paying necessary filing fees to the account of the Authority. The package includes the delivery of a power of attorney to the Authority, if the power of attorney signed by the Client is at hand at the time of the filing of an application. The package also includes possible claiming of priority and delivery of electronic access codes of the priority documents to the Authority for the retrieval of documents, if the codes are at hand at the time of the filing of an application.

NB! As to the International trademark or design application, costs of foreign bank transfers are additionally charged, as per the price list above.

In addition to the package, most of our clients also require services that are not included in the package. For example, a trademark search and a goods and services list are often made. It is often advisable to include a seniority claim of the corresponding Finnish trademark, when preparing an EU trademark or an international trademark application designating EU. When designating the United States in an international

trademark application, it is necessary to include an intent to use notice to the application, etc. We will be happy to give you a cost estimate for budgeting when requested.

3. Handling and reporting search report, official communication, decision, third party observation, opposition, or appeal, without attorney comments

Receiving documents/decision, docketing details and deadlines to the database, delivering documents to the Client electronically.

The filing of the application is almost always followed by a number of smaller actions, such as receiving and reporting of Search Reports or Office Actions. Further, there are almost always actions that require a significant amount of work, such as responding to an Office Action issued by the Authority, or responding to an Opposition filed by a Third Party.

In addition to the package, most of our Clients also require services that are not included in the package. For example, studying an Office Action, Decision or Opposition filed by a Third Party, preparing a response or providing instructions for a response to a foreign patent agent, submitting a response to the Authority or delivering instructions for a response to the foreign patent agent. Before the grant of a patent, both the Finnish and the European patent application require translation of claims and payment of official fees. We will be happy to give you a cost estimate for budgeting when requested.

4. Submitting an assignment to a foreign agent to file an application with a local Authority Compiling documents required for filing an application, delivering same to a foreign patent agent electronically, submitting an assignment to a foreign patent agent electronically, monitoring filing of an application, reporting, docketing filing details to the database and starting maintenance fee monitoring.
